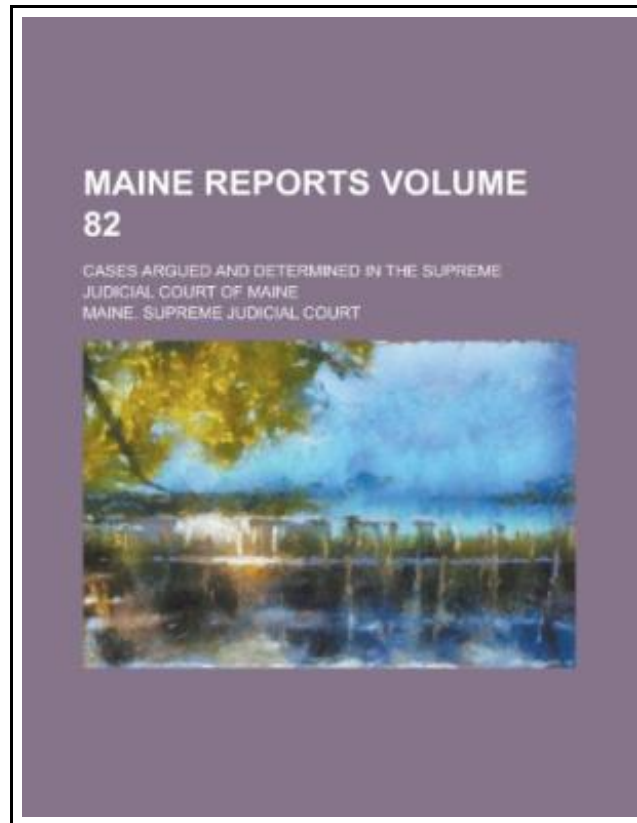

Excerpt: . . . and in the exercise of the authority with which they are invested by general law, act not as agents of the town but as public officers, deriving their power from the sovereign authority. They act upon their own responsibility and are not subject either to the control or direction of the inhabitants of the town, but are an independent board of public officers, vested by law with the control of all matters within their jurisdiction, and performing duties imposed by general law. *Brimmer v. Boston*, 102 Mass. 22; *Burrill v. Augusta*, 78 Maine, 118; *Woodcock v. Calais*, 66 Maine, 235; *Estes v. China*, supra; *Lemon v. Newton*, 134 Mass. 479; *Child v. Boston*, 4 Allen, 41; *Tindley v. Salem*, 137 Mass. 173-4; *Cushing v. Bedford*, 125 Mass. 528. Though chosen and paid by the town, and for many purposes its agents, (as in making contracts within the scope of their authority about the affairs of the town, or acting under the direction of the town in matters pertaining to its corporate duties, *Deane v. Randolph*, 132 Mass. 475,) yet these officers do not sustain this relation in reference to these particular duties in question. In this respect they are a part of the municipal government, in the performance of their public duties, and are not servants or agents of the municipality by whom they are chosen and paid, rendering their principals liable for their acts, any more than are officers of a fire...
